- Fund Balances as of May 2023 (reconciled): General Fund-\$3,556.89, Escrow-\$29,878.70, Citizens Money Market (MM)-\$40,025.76
- Fund Balances as of June 26, 2023 (unreconciled): General Fund-\$3,115.47, Escrow-\$29,455.51, Citizens Money Market (MM)-\$40,025.76
- Investments: per May 2023 statement \$751,390.37
- Current bills: \$7,037.33 (includes \$3,045.62 Diocesan Common Mission Support, formerly called Diocesan Pledge, \$2,489.10 Church Insurance).
- \$765.15 credit for Church Pension Fund (CPF) represents a reduction based on former Letter of Agreement with Fr. Jackson, based on change in his age.
- St. Luke's Development Corporation, St. Luke's Steel Band and St. Luke's Senior Housing should not be on the church insurance policy. This is a new insurance company with a different plan than we're used to. Per V. Stanley this will save us ~\$12K. They will be given 30 days' notice.
